- Submit the completed original or certified copies of your documents for filling in the interim personally to our office.

- Applicants with English language proficiency and other foreign language certificate may be an added advantage in some cases.
- Applicants are to submit 20 coloured passport size photographs during processing of documents.

TERMS AND CONDITIONS

- The once only membership fee is non-refundable.
- All successful applicants shall be issued with a membership and International Student identity cards.
